Sub:- No-Objection Certificate regarding the affiliation of Guru Nanak Dev Public School ,Harchowal Road ,Qadian, Distt. Gurdaspur with the C.B.S.E New Delhi.

Sir,

With reference to the subject cited above:

1. The requisite No-Objection Certificate is issued by the Punjab Govt. after the careful consideration over the recommendations made by the district education officer (Secondary education) and directed education department(Secondary education), Punjab Chandigarh on basis of documents produced by the management of the school along with affidavit, Subject to the following conditions:-

That on any complaint /Inspection in future if it would transpire that you furnished a wrong information in an application to the Govt. at the time of obtaining No-Objection Certificate or did not comply with the instructions of Punjab Govt. issued from time to time and also did not comply with the written conditions mentioned in the affidavit, in the event this No-Objection Certificate can be withdrawn at any time.

2. That it would be compulsory to teach Punjabi upto 10<sup>th</sup> standard in your school and CBSE New Delhi would compulsorily conduct the examination of Punjabi in such schools and it is also said that in the event of failure to do so the No-Objection Certificate would be withdrawn forthwith.
3. The school management would completely comply with the notifications issued by the Punjab Govt. under R.T.E. Act, 2009 and rules framed for the Punjab state under R.T.E. Act 2009
4. After obtaining the affiliation with CBSE new Delhi, The school management would be bound to make the payment of pay and other allowances to the Teaching and Non-teaching staff of the school like, Govt. employees through account payee cheques ,failing which the No-Objection Certificate would be withdrawn forthwith.
5. Youself and your management would ascertain that you would furnish the information of any kind required by the district education officer of your district or by any Senior Officer of the Education department and would give necessary co-operation as well.

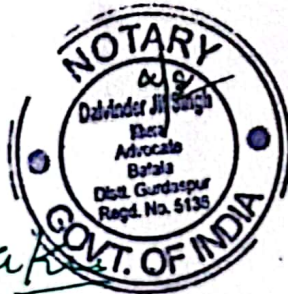

6. The file is being returned in original to Guru Nanak dev public School, Harchowal Road Qadan, Distt. Gurdaspur

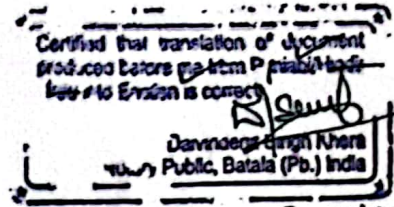
