Sub:- For the Purpose of Section 18 of the free and compulsory education of children Act, 2009, a certificate of recognition for a school under sub rule (4) of rule 11 of the free and compulsory education of children Rules, 2011

Respected Sir and Madam,

In reference to the letter received from you and subsequent correspondence/ with the school, dated from 01-04-2020 to 31-03-2023 for issue Guru Nanak Dev Public School Qadian, block Qadian-1, from class Ist to VIIIth temporary recognition for the three years.

This approval will be considered valid only after the fulfillment of the following condition.

Terms:-

1. The time for sanction of recognition cannot be extended and in no case is a guarantee for recognition/affiliation beyond class VIIIth.
2. The school shall strictly comply with the Right of Children to Free and Compulsory Education Act 2009 (Annexure 1) and the children to compulsory and free education rules 2011 (Annexure 2).
3. School shall provide free and compulsory education up to the completion of elementary education to the first grade and 25% of the class to all students belonging to weaker sections and disadvantaged section belonging to them. This rule will be applicable to Pre-primary classes as well.
4. For the students referred to in Paragraph no. 3, the school shall make Provision as per sub section 2 of section 12 of the act and shall establish a separate bank account for the same.
5. The school will not collect any compulsory fee from any parent or Guardian from any action.
6. The school will not entertain any admission to:-
 - a) Any child who does not have proof of birth or
 - b) If such child is admitted during the indicated or extended period (for admission) if admission is granted.
 - c) Shall ensure schooling on the basis of religion, caste, place of birth or any of these factors
7. School ensure that:-
 - a) No enrolled student shall be suspended or withdrawn from any grade until his elementary education is completed.
 - b) Physical or mental Punishment shall not be given to any student.
 - c) No student shall be required to pass any Board Examination before completing elementary education.
 - d) According to rule 21, every student will be awarded a certificate after receiving elementary education.
 - e) Students with disabilities, disabilities or special needs shall be admitted under the law.
 - f) Teachers appointed under sub-section (1) of Section 23 meets the Qualifications. If they are already appointed, then they have their own requirements minimum educational qualification to be completed within 5 years of entry into employment from the date of enactment of the Act.

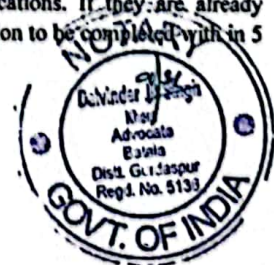

h) Teachers shall not engage themselves in any form of Private tuition.

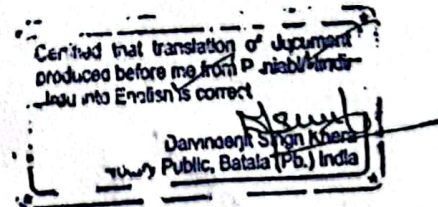
8. The school shall follow the time table and Curriculum distribution Prescribed by the competent governing body/authority
9. The school shall admit children in proportion as specified in section 19 of the Act.
10. The school shall follow the norms as per section 19 of the Right to Education act. The facilities shown as per previous inspection, If any are as follows:-(As per report)
 - a) Area of school. (As per report)
 - b) Total built up area. (As per report)
 - c) Area of sports.(As per report)
 - d) Number of classrooms.(As per report)
 - e) Head teacher cum officer cum storage room.(As per report)
 - f) Availability of reading material/sports equipment/ library material. (As per report)
11. No unrecognized class will be taught inside or outside the Premises of the same school.
12. The school building and structure of playground shall be used only and exclusively for educational activities and skill development of the school.
13. The school being run by a society registered under (Act number 21 of 1860) Act or being Run or working or sometime by any public body
14. The school shall not be conducted for the benefit of any individual class or individual group
15. The accounts of the school should be recorded by a chartered accountant CA and a table of Accountants should be prepared as per rules every year the time table will be sent to the District Education Officer (DEO) for information.
16. Accredited identity of your school is per mentioned above please note it down and mention this signature number in future correspondence.
17. The school shall submit all such reports and information to the district education officer or the director education department from time to time and shall be bound to furnish such information to the state government or the local administrator as may be directed by them from time to time deficiency is removed by the school which are necessary for him to be panchkrit.
18. Ensure that the registration of the organization is renewed.
19. Other conditions are attached as per Annexure 3.

Note:- This recognition is issued on the condition that every year the school will deposit building safety certificate, fire safety and water purity certificate from the concerned department as per Period till 30th April at the office of the undersigned.
